3. Headquarters :- The headquarters / office of the Trust is located at Railway Station Road, Bargarh with its postal address as At/PO/ Dist- Bargarh-768028 (Odisha); while the headquarters / office of the Trust can be changed to alternative location(s) in Bargarh as also branch office(s) of the Trust can be opened / functioned at different centers in the State & outside the state, depending upon exigencies, by decision taken by the Trust Board.

4. Composition / Trusteeship:

- The Trust is constituted with the 05(five) Permanent Trustees named above and they constitute the General Body of the Trust.
- (ii) Shri Dasari Shyam, a Permanent Trustee, is accepted as the Author & Managing Trustee of the Trust and Shri Valluri Srinivas, a Permanent Trusty, is accepted as the Secretary of the Trust. The expression 'Author & Managing Trustee of the Trust', unless repugnant to the subject or content or objectives of the Trust, is made to include his successor, assigns, nominee, or representative.





(8) Accounting Year's Accounts & Funds Management -

(i) The Trust will follow as its accounting year 01st April to 31st March the following year, in conformity with the standard Financial Year being followed in the country. As such, in the event of any change coming upon in the country as to the norms / standards of Financial Year, the Trust shall also adopt such changes.

(ii) The Trust will follow the principle of 'single entry book-keeping' for its financial transactions / management.

(iii) The Trust Board shall be competent & responsible for mobilization of required funds and its proper management / utilization / expenditure.

(iv) The Trust will open & maintain one bank account in any commercial bank in the name & style of the Trust and such account has to be operated upon jointly by the Managing Trustee and the Secretary of the Trust. Depending upon exigencies in future, the Trust Board can decide for maintaining second / subsequent bank account(s) following the same principles. This is to the exclusion of the bank accounts required to be opened / maintained for the institutions under management of the Trust, with decision of the Trust Board.



Therefore, for implementation of the programs & projects of the Trust, the Trust Board will be competent to raise required funds from all permissible sources, including by borrowings from banks / other authorized lending agencies even by mortgage the property of the Trust to secure such loans and in such cases the Managing Trustee and the Secretary will execute the relative loan documents as authorized signatories for the Trust.


